**EXPERIENCE AND RESULTS**

- Obtained 8th Circuit reversal of an order from the W.D.Mo., which had denied SAKG's motion to compel arbitration in favor of individual executives of a company who were not personally parties to the arbitration agreement at issue; the 8th Circuit reversed and ordered arbitration as to all parties.
- Successfully defended 8th Circuit appeal, resulting in affirmance of decision dismissing third-party intervenor complaint against SAKG's client for lack of standing.
